TERMS AND CONDITIONS – CARO LONDON

Payment Terms:

1. Account Customer payments - Strictly 30 days net from invoice date on account approval.
2. New Customer payments - Advance Payment by pro forma.
3. We accept the following payment methods for overseas payments: CHAPS transfers, Paypal or Credit card but NOT American Express.
4. Orders must be cancelled within 14 days from the date of issue. Manufacturing of goods for orders will commence after this time, therefore orders cannot be cancelled.
5. Any cancellations of orders will incur a fee of 50% of the total value of the order. Failure to comply with this procedure may result in legal proceedings.
6. Interest will be charged on overdue balances in accordance with the Late Payment of Commercial Debts (Interest) Act at the rate of 8% above the prevailing Bank of England base rate.
7. All sample requests will be regarded as orders and must be paid for.

Order Value and Shipping

1. Minimum order \$400 US Dollars.
2. Carriage is included in our pricing and goods are sent by courier to the store in all USA mainland destinations. Other destinations will be discussed according to the order and location.
3. Whilst every attempt is made to complete shipments in one delivery, we reserve the right to make part deliveries.

Return Policy

1. Claims of shortages or discrepancies must be notified in writing within 7 days of delivery.
2. **Damaged or defective goods** - if on delivery goods are found to be defective in merchantable quality, the customer must notify **Caro** in writing within 7 days otherwise no liability can be accepted by **Caro**.
3. Caro London is under no obligation to accept the return of perfect garments correctly supplied.
4. Returns will not be accepted unless by prior arrangement with **Caro** and then only if accompanied by a letter on headed paper giving the reason.

Liability
